This month we are diving into stewardship, which I love and always have. Stewardship is about having explicit conversations about tangible ways we can more deeply follow Jesus.

Why do you give? Who do you give to? Just church? Just the food pantry? How do you determine what to give? What does it feel like to be someone who contributes your money, your leadership, your volunteer hours, your abilities?

I remember being confirmed in 8th grade and after we were confirmed we were given offering envelopes, which in all honesty is probably not the most useful way for the church to spend money—buying offering envelopes for 8th graders. However, the whole thing felt wildly empowering to me. It made me feel like an equal. It made me feel sort of powerful, like I had something to contribute.

I remember receiving a pledge card. Mind you, I was 14 and didn't have a steady income, but I did babysit. So I sat down and did the math. If I babysat for x amount of hours at x rate, then over the course of the year I might make \$900ish dollars. Ten percent of 900 is 90 so my first ever pledge was for \$90 at the age of 14 and boy did I feel proud to put that slip of paper in the offering plate that day.

I give because a long time ago, I was asked to give and it felt really good to do so and it still does. I give because the gospel changed and changes my life and I love that God makes room for me—ME—to be a collaborator in this work.

Which brings me to my next point...

Over the years we have had unsheltered and low income people come to us for worship; some who just come for a Sunday and some who become integral members of our community. It is so often the instinct of well-meaning church people to want to GIVE of ourselves to people in need.

What if the thing that we really have to offer these folks is a place where they can give of themselves and feel the kind of empowerment that I felt as an 8th grader giving my \$90 a year to the church? What if, instead of meeting these people and treating them like they are in need, we (unlike just about every other place they go) treated them like they have something to give. One of these approaches teaches them that they are lacking. The other teaches them that they are valuable contributors to the community.

A few years ago we had a gentleman who was with us from the street and throughout the month he would need help. He needed to use the restroom, mostly. He slept on our sidewalk. He plugged his phone into our outlet. But boy howdy, you'd better believe that when his monthly check came in, the first thing he did was come and find me to give \$60 to the preschool...because he loved kids and he was grateful for our kindness.

Did it feel kind of odd to take money from a man that I was likely going to feed later in the month? Yes. Did it also feel like the right thing to do? Yes.

There is a lot of messaging in the world that communicates to people, especially the poor, that we are disposable, useless, of little value, etc. But giving just might be one way that God gives us to counter these messages and to live into the truth of our baptisms: we are whole, we are holy, we are valued, we are contributors and co-creators with God in sharing his love.

I pray you will be blessed in your giving this coming year.



Loaves and Fishes Food Drive

October is Loaves & Fishes month at St Peter's. Please bring your contributions of non-perishable food items and small toiletries to the church on Sundays or to the preschool Monday-Friday.

In 1978, area churches and community organizations came together to open the first pantry at the Women's Club. In 1979, OBEF (Ocean Beach Emergency Food – aka Loaves & Fishes) officially become a non-profit helping food insecure families and individuals.

Almost 50 years later the Pantry continues to help provide food to over 1,000 men, women, and children per month in the 92106, 92107 and 92110 area.

PACIFICA SYNOD/ELCA NEWS

What Does My Offering Do?

The ELCA recently released this **Mission Support video** that details how congregational offering supports ministries around the world through our synods and churchwide organization. Of the \$1.6 billion given to ELCA congregations and worshiping communities as regular offerings, most stays with the congregation to fund its vital ministry. A portion—about 5% on average becomes Mission Support, given by congregations to our synods. Mission Support ensures that synods can find and equip leaders of all ages and deploy an array of ministries, including those of synod companions and those for youth and young adults. Our synods, in turn, give a portion of that Mission Support to our churchwide organization to fund our shared work across the country and around the world. STEWARDSHIP COMMITTEE

As we enter stewardship season we wanted to be sure you know the many ways you can make your contributions to St. Peter's by the Sea in the ever-changing world we have.

- 1. We have the traditional way of cash or writing a check and putting it in an envelope (those provided to members/regular visitors or using the ones in the pew) and placing it in the offering plate that is passed around on Sundays during our offering time.
- 2. The next way is through electronic giving using the St. Peter's Web site to make one-time donations or set up recurring donation.

You can do this by going directly to St. Peter's website to make your donation at www.stpetersbythesea.org

The system that we use, Vanco, allows us to take credit card payments, as well as electronic payments from an individual's bank. There is a small fee associated with the use of a credit card.

Our program is also set up for people to create a recurring donation. If you would like to give so much per week or so much per month or year, this can be set up directly on St. Peter's website. Look for the 'general operating' fund button.

- 3. A new method is that every Sunday our bulletin contains a QR code by the offering section which will take an individual directly to our website and an opportunity to make a donation.
- 4. We also often receive special donations for unique circumstances, such as the fires in Los Angeles, as well as tragedies that occur elsewhere in our nation and world. A good example of this was our global refugee participation, helping those that had come to the United States expecting assistance as these people were approved refugees from Afghanistan and other locations. This can also be done via all the above methods.
- 5. Many who reach retirement age of 70 1/2 can use the Qualified Charitable Distribution (QCD) or at age 73 can use the Required Minimum Distribution (RMD) which allows you to transfers funds directly from your IRA to St. Peter's and makes it a non-taxable event in the year it is given.

No matter the way you choose to give in this electronic age, we truly appreciate getting a pledge card during our annual Stewardship Drive.

ENDOWMENT COMMITTEE

Implications of new tax rules on deductions: Now is a good time to donate to the Church and the Endowment Fund Principal.

Key advantages for accelerating giving before the end of 2025 are highlighted below. One way to accelerate giving to maximize tax deductions is to donate to a donor-advised fund, or DAF, (often with appreciated stock held more than one year) and then use those DAF funds to recommend grants to non-profits including your church in subsequent years. Many investment companies have donor-advised funds, and Fidelity Charitable provided these points and additional ones online this summer. You might also consider giving directly to the St. Peter's Endowment Fund, now, or as part of giving in the future from a DAF.

On July 4, 2025, the One Big Beautiful Bill Act (OBBB) was signed into law.

New limits to deductions for itemizers in the top tax bracket

The new legislation caps the tax benefits of itemized charitable deductions at 35%, even for those in the 37% marginal tax bracket. In other words, these high-income filers donating \$1,000 would receive a \$350 deduction instead of the current \$370. This change goes into effect in the 2026 tax year.

Implication: Donors in higher tax brackets who are considering a significant philanthropic gift may want to think about accelerating their gift to 2025 to maximize their deduction under the current marginal rate before the new cap goes into effect.

New floor on deductions for itemizers and corporations

Effective in the 2026 tax year, itemizers who make charitable contributions will only be able to claim a tax deduction to the extent that their qualified contributions exceed 0.5% of their adjusted gross income (AGI). For example, a couple with an AGI of \$300,000 could only deduct charitable donations in excess of \$1,500.

Implication: High-income individuals who itemize deductions should carefully consider the timing and amounts of their giving, and the strategies to maximize their deduction. For example, a bunching strategy or an approach of making larger gifts with less frequency can be more effective under the new rules

New standard deduction amounts: Beginning with the 2025 tax year, the standard deduction, which was raised by the Tax Cut and Jobs Act of 2017 (TCJA), increases further by \$1,000 for single filers and \$2,000 for married couples filing jointly. This brings the deduction to \$15,750 for single filers and \$31,500 for joint filers, with future amounts indexed for inflation. But note below the State and Local Tax Deduction has also increased meaning more people owning homes in California have a tax advantage in itemizing deductions.

Adjusted gross income limits: The new law permanently extends the existing ability to deduct up to 60% of AGI for cash contributions to 501(c)(3) public charities.

Estate and gift tax exemption: The federal estate and gift tax exemption has been increased to \$15 million for the 2026 tax year, with future adjustments for inflation. This means the majority of estates (more than 99%) will not be subject to federal estate taxes, making lifetime charitable giving the primary way to receive a charitable deduction for most taxpayers.

Several other updates are worth noting for their potential impact on charitable giving strategies and decision-making.

• Increased state and local tax (SALT) deduction Under OBBB, the SALT deduction for itemizers has been increased from the \$10,000 set by the TCJA to \$40,000. Going into effect for the 2025 tax year, the cap will increase annually by 1% through 2029, and then revert to \$10,000 in 2030. This increased deduction phases out for taxpayers with incomes over \$500,000.

Key takeaways and considerations

In light of the 2025 tax law changes, donors should take a fresh look at their charitable giving strategies to ensure they are maximizing both impact and tax efficiency. The introduction of charitable deduction for non-itemizers may expand participation in giving, while high-income donors may face reduced value from charitable deductions in the future. All of this could make 2025 a potentially strategic time to give. Donors and their advisors should consider:

- Timing of contributions Accelerating contributions in 2025, perhaps using a <u>bunching strategy</u> may yield greater tax savings. A <u>donor-advised fund</u> may be worth considering for this purpose.
- Thinking beyond cash A mix of cash and non-cash gifts may lead to greater impact as the legislation introduces new
 complexities and considerations for itemizers.
- Work with a trusted professional Donors should engage with a tax professional or financial advisor to tailor a plan that aligns with their values and goals.
