#### **PASTOR'S REPORT**

When I first joined St. Peter's as your pastor, coming out of the lock down, after more than two years of a pastoral vacancy, the image I had for us was that of a bunch of canoes all pointed in various directions; joyful but somewhat unfocused and windswept after the craze of the past few years.

Here at the start of 2023, we are a growing community that is moving together more and more as one, with areas of focus and dedication.

This year began in January with a council retreat where we set four goals for St. Peter's. Here are the goals and the ways they were executed:

- 1. Fiercely pursue connection between members and within the wider community
  - Lenten Soup Suppers, Easter Brunch, VBS, God's Work Our Hands Sunday, Stewardship Sunday, Women's Book Study, Beer and Carols, Christmas party, Hiking and Biking groups, and Community Pet Blessing
  - We welcomed 15 new members into the congregation
  - We have **strengthened our relationship with our preschool** and partnered with them for all of their family events like Mother's/Father's Day events, Thanksgiving and Christmas programs. We painted their classrooms and they join with us on Angel Tree and food drives
  - We have strengthened connections with Susan Fleming @ TACO, **built a network of connections when it comes to homeless services in San Diego**, built relationships with leaders at Water's Edge Faith Community, All Souls' Episcopal, Jewish Family Services, Agape San Diego, and Shepherd of the Valley Lutheran Church

#### 2. Offer opportunities to take refuge in the Word of God

- Lenten and Advent evening prayer services, Holy Week Services, Sunday worship, Easter Worship on the Cliffs
- Short Term Bible Study courses as well as longer-term bible studies on Wednesday Nights
- Choir, prayer chain, home communion to sick and elderly folks

#### 3. Experiment! Send up new shoots and branches!

- Stewardship Team developed a St. Peter's Gift Policy for major gifts
- The creation of our "Made in the Image of God" art wall in the narthex which tells the story of Jesus in a way that de-centers whiteness
- Racial Justice Taskforce has worked behind the scenes to put together a team of volunteers from 3 different churches to **co-sponsor a refugee family in 2023**
- Scott Walls has been leading a **Homelessness Focus Group**, discerning and learning more about homelessness in San Diego and how St. Peter's can thoughtfully respond to our homeless neighbors
- Darlene Truver organized our first neighborhood Trunk or Treat

- St. Peter's partnered with 3 other churches and Thrivent Financial to host the *Wine to Water* Event which raised almost \$5K for Humanity Showers
- We are in ongoing negotiations with **Dish Wireless** to put two more cell towers on the basketball parking lot which would be an additional source of income

#### 4. We also had a focused list of property improvements to accomplish

- Fletcher Miller led us through the "Lighting the Way" campaign to raise \$40K to replenish our building fund and to install 39 solar panels
- Our two main parking lots were repaved
- Plans have been underway to replace the heating and cooling units for the sanctuary

The thing about the pastor's report is that it's not mine. The things that have been accomplished under my leadership this past year are the efforts of so many dedicated people. I continue to give thanks for this congregation; for the joyful welcome that is exuded by long-time members, for the energy and perspective of new members, for our incredible council and deacons, for our reliable staff, and for the chance to gather each week to receive the Word and the meal and be drawn again and again into God's ongoing activity in the world.

#### **CHRISTIAN SERVICE COMMITTEE**

As we continued to emerge from the grips of COVID, St. Peter's outreach to our neighborhood, our city and around the world showed our eagerness to serve. The Christian Services Committee yearly programs along with some special projects demonstrated the abundance of love and care our Congregation shares with all.

We continue to support the homeless and the hungry through two food drives for Loaves and Fishes (OBEF) and through two food drives for Lutheran Social Services. Our Preschool Families continue to support these programs. Our outreach program for the Hungry and the Homeless continues every first Friday of the month as we help serve a hot nutritious meal at Third Avenue Charitable Organization (TACO).

Other specialty programs from this year included supplying clothing to a Refugee Family from Haiti with our Spring Tulip clothing drive. This work was in association with Shepherd of the Valley Lutheran Church. In August we collected School Supplies again with the support of the Preschool families. These materials were given to Lutheran Border Concerns Ministry to support the school children that live south of our border.

In September, St. Peter's once again participated in the ELCA day of God's Work Our Hands. After sharing a nourishing meal together, we began our goal to reach out into our community and make a positive impact. One group went out to clean up the trash in our streets to support and protect our natural environment. Others wrote cards of encouragement and prayer to our homebound church members and our neighbors that are in assisted living facilities. A third group assisted in putting together small care packages for our homebound members and local seniors that are supported through Peninsula Shepherd Senior Center. It was an inspirational day for the members of St. Peters to get out into our community and share our compassion.

We ended our year with the Angle Tree Project by delivering over 120 gifts to the children at Our Saviors' Lutheran Church and to Lutheran Boarder Concerns Ministry. Once again, we are so grateful to our Preschool families that helped in supporting this program.

A surprise gift from John Smart's employer provided brand new clothing articles that they could no longer use. Our Church Mice team stepped up to assist in removing official embroidered labels so that this clothing could be donated for the homeless through our relationship at TACO.

In July we launched a Homelessness Task Force to help educate us on the significant homeless issues facing our city and to understand what is being done, what works and what is not working to improve this city-wide crisis. We continue our investigation work by inviting knowledgeable speakers, discussing the many homeless statistics and having open, honest discussion amongst the group. With the complexities of this subject, we recognize our work will take time to gather, process and allow time for discernment. This will hopefully lead us to a direction on how we as a Congregation can make a positive impact on the lives of the homeless and those threatened by homelessness through friendship and compassion.

My closing thoughts are of amazement. Our little congregation does so much for our neighbors near and far. We gather clothing and supplies for those less fortunate than us. We give our time to support these neighbors and causes through the kindness of our hearts. Beyond collecting these many needed items and giving our time, St. Peter's provides much financial support through general donations and our Endowment Fund. Our hearts are bountiful and continue to shine in so many ways.

#### **Vacation Bible School**

VBS AUGUST 1-5, 2022 was a great success. There were 13 children and 17 volunteers. All of whom had a fantastic time. From 9 am to 12 noon there were activities such as storytelling, music, crafts and games. The children were in two groups, younger and older, and enjoyed each other's company. Special thank you goes to Darlene Truver, Solveig Fuentes, Colleen Doering and Travis Boelter for their extra time and effort in making this VBS very special. The group leaders helped keep the children together in their group and participated in all the activities. Group Leaders for the younger children were Julie Anne Hughey and Penny Holden assisted by Ava Rahilly and Marley Buddington. The older children were led by Jim Grutkowski and Brenda Johnson. There were five youth that assisted the teachers that were very dedicated to making VBS a success. Travis Boelter was assisted by Catrina Holden and Shelby Boelter. The kitchen snacks were taken care of by Lora Thompson and Elaine Lauger. Ellen Schmeding and Kendra Thompson helped out for a day as well as helping out in the background. Our own Pastor Bekki started the day and closed the session in a chapel format. Colleen Doering's artistic talent helped set the stage for us all.

#### FELLOWSHIP COMMITTEE

Our constitution says: "The Fellowship Committee shall seek to promote Christian Fellowship among all members of the congregation."

The fellowship activities in 2022 have been fairly robust, with current activities including: Coffee Hour after Sunday Worship, Lenten Soup Suppers, Easter Brunch, a Christmas Party, the Women's Christmas Tea, GiGGLES (lunch/crafts), a Hiking group, Hand and Food (card game), a Bicycling group, and a Women's Book Study.

The weekly Coffee Hour after the Sunday service has returned to being a member hosted event. This gathering provides an ideal venue for visitors and new members to become part of our community. Attendance has increased in 2022, slowly climbing from a low of "2 pots of regular coffee" all the way up to "5 pots of regular coffee" on some days. Many thanks go out to those that have helped this gathering by providing snacks, manual labor, donations, or good conversation.

Small changes have been implemented in the coffee service to reduce plastic waste. We have started a switch to reusable cups, plates, and coffee stirrers to lessen our waste plastic output. We hope to continue our efforts and further refine our operations in the coming year.

One event of 2022 that calls for special mention is the celebration of the 75th anniversary of the founding of St. Peter's by the Sea. This event gathered much of the St. Peter's community, including people that we have not seen in many years, provided an opportunity to share the history of our church with new members and refresh the memories of those that have been here for an extended period of time.

Activities are starting, stopping, or changing on a regular basis, being led by motivated members of the congregation. If <u>you</u> are interested in starting an event or group that would provide Christian Fellowship opportunities, please contact the church and we can help you get it started.

This year the preschool has been again able to remain open the entire year and the staff has done a fantastic job in another year filled with COVID and other challenges. Dori, Bekah, their staff, along with Janine (Office Administrator) and Pastor Bekki have been working hard all year, finding innovative ways to run the Preschool, keeping up on everchanging mandates, and keeping the preschool full of children.

In addition, Fletcher Miller and his building maintenance volunteers met the various maintenance needs of the preschool. Brenda Johnson continues to do a fabulous job keeping the accounting records for the preschool. Alyssia helped with the social media outreach and gave good insight as a parent to the committee. We thank them for their efforts this past year.

The preschool was able to have many events, in addition to the great teaching, including the Trike-A-Thon, a trip to the Pumpkin Patch, Halloween Trunk-or-Treat, Thanksgiving performances, and Christmas performances. St. Peter's hosted goodies after the two performances by providing the pies, cookies, coffee and tea, as well as decorating and serving at the events. This year, St. Peter's was able to also host the Trunk-or-Treat event, as well as the Mother's Day and Father's Day events. Thanks to all who volunteered and donated food – what a wonderful outreach to our preschool.

In addition, the preschool continued to partner with our church in several of our community outreach ministries. They were a part of our Lutheran Social Services July food drive collection and our Angel Tree program in December.

The preschool is ending the year with a surplus and they were also able to replace the old picnic tables and the Director's very old computer.

#### **PROPERTY COMMITTEE**

There were two major projects completed by the Property Committee in 2022, the addition of solar panels to the roof of the Fellowship Hall, and the repaying of two of the three parking lots.

In Dec. 2021 the *Lighting the Way* fundraising campaign was launched to repay the Building Fund the \$39,850. that was used to pay for the solar system. The campaign ended in Spring 2022 and was very successful, raising well over \$40,000. A huge "Thank you!" to all who contributed. The solar panels went "live" on April  $22^{nd}$ , which just happens to be Earth Day, the annual worldwide celebration that marks the birth of the environmental movement – a very fitting birthday for our own contribution to protecting the air we breathe and the planet's climate! In the 7 months of 2022 the panels generated 21 MWhr, which is over \$5000 worth of electricity. In April 2023 we will get a "true up" from SDG&E and get a measure of the performance of the panels for the first year.

In August we had the main parking lot and the preschool parking lots resurfaced and restriped. As part of that process, we increased the size of the parking spots facing Point Loma Ave. Previously, all slots had been 8 feet wide, all are now over nine feet, and two are a full ten feet wide for extra-large vehicles. In 2023, after the new cell towers are installed, we will repave our basketball parking lot.

Ongoing projects include installing a new heater/air conditioner in the sanctuary, and the addition of two more cell towers to our property. We have had five companies come out to discuss and bid on the heating/air conditioning needs of the church, but none so far has proven entirely satisfactory. A sixth company has been contacted, so hopefully we will get a successful quote soon. The negotiations with Dish Wireless for the two new cell towers have continued for months, while they created engineering drawings and submitted plans to the city for a building permit. As of this report, we are very close to a final contract, so hopefully soon we will have two more cell towers in the other two corners of the basketball parking lot. Each tower generates roughly \$1000/month in rent, a welcome addition to the church budget.

The Property Committee also took on a variety of other important projects over the year such as painting of two of the Preschool classrooms, replacing screens that were damaged during a break-in attempt, repairing various plumbing issues, and working on the Preschool computer.

For 2023 we look forward to initiating some new projects such as an LED sign for our corner, creating a full-court basketball court, adding a couple of water stations on the grounds, sponsoring a Little Free Library, and several others.

Volunteers are needed for several of these projects, so please contact Fletcher Miller if you want to help.

#### **RACIAL JUSTICE TASKFORCE**

The Racial Justice Taskforce was formed in 2021 after a group engaged in a book study with Pastor Rick Schowalter in 2020 reading the book "Waking Up White" which was followed by Pastor Bekki inviting St. Peter's to join, with other churches, an ecumenical study put out by the ELCA entitled, "Dialogues On Race". These activities were spawned by Carolyn Irby and Pastor Rick in the wake of the George Floyd death in Minneapolis, MN.

The taskforce developed a statement of who we are in 2021: "The Racial Justice Taskforce at St. Peter's by the Sea Lutheran Church believes that all people are made in the image of God and we live in a world that often denies the image of God in people of Color. We believe that everyone is simultaneously 100% saint and 100% sinner, and therefore we will hold fast to our identity as God's beloved while simultaneously renouncing the sin of racism that has seeped into our own worldview.

"As children of God, we are called through the baptismal waters, to work towards justice for all, especially people of color, and we will do this work beginning with our context at St. Peter's through raising awareness, education and to whatever work the spirit leads us next!"

The taskforce in 2022 continued the art installation project which has now filled the entire wall as you come into the sanctuary. The intent is to remind us of how Jesus and his ministry is seen from the eyes of other races and cultures.

During Lent, a book study was offered to St. Peter's and a group joined in reading "Broken Paradise: A Novel". Although a fictional book, it gave us insight into how those that are refugees manage in a new world while still being very concerned about their homeland and those they have left behind.

We also had Jewish Family Services come to St. Peter's to give us information on their role as a Refugee Resettlement Agency. After this the taskforce continued discerning what and how to make this taskforce relevant to our church and the world around us and we began to explore ways to support refugees in San Diego.

We began engaging with Shepherd of the Valley Lutheran Church and All Souls' Episcopal Church and have been in contact with Jewish Family Services to become a support system for a refugee family in 2023. Trainings will start in January and many areas are available for our congregation to help support this effort. #### **STEWARDSHIP COMMITTEE**

We had a wonderful committee again this year for Stewardship activities. This included Pastor Bekki, Richard Doering, Brenda Johnson, Elaine Lauger, Darlene Morrow-Truver, John Smart and myself, Ellen Schmeding. This group met monthly for much of the year to plan our activities.

Richard introduced us to Lisa Marie Higgenbotham, Regional Gift Planner for the ELCA Foundation, who met with our committee and other interested congregational members to discuss the creation of a Gift Policy. With Lisa Marie's guidance, we drafted the policy and completed the review and approval with the Church Council. This policy governs the acceptance of gifts by St. Peter's and provides guidance to prospective donors and their advisors when making gifts to our congregation. The provisions of this policy apply to all gifts over and above regular giving, offering, or pledges, memorials or specific campaigns or initiatives. Gifts will be accepted when they support the mission, purpose, and procedures of St. Peters by the Sea.

The committee also looked for ways to continue telling the story of our stewardship work as a congregation. We used the "Lighting the Way" solar program campaign as an opportunity for education and thanksgiving for all those that made a donation to this important campaign.

A time and Talent listing was also updated which will be shared with the congregation in the near future in order to ensure we are making opportunities to serve known to all those that worship at St. Peters.

We decided to return to the Stewardship Program titled "Consecration Sunday" for 2022 and our committee members participated in a number of ways. Pastor Bekki connected with Pastor Jon Doolittle who is knowledgeable about the program and agreed to be our guest speaker. Brenda Johnson, John Smart, and Fletcher Miller participated as announcers during the church services leading up to Consecration Sunday on October 10; Darlene Truver planned the luncheon and special dinner for Pastor Jon; the Council and Stewardship Committee and Elaine Lauger served as the financial lead for the program. We had good attendance for both the church service with Pastor Jon as well as for the special catered taco luncheon. Results included the following:

- A total of **41** giving units completed *Estimate of Giving Cards* this year compared to 39 last year.
- A total of **24** of these giving units increased their financial commitment above last year's amount. Those who began pledging this year included **12** of our congregants.
- Those pledging this year committed a total of \$190,251. The amount pledged last year was \$188,388; this year we saw an increase of \$1,863.

#### AUDIT COMMITTEE

#### Financial Review of St. Peter's Lutheran Church - Year 2021 Records

2021 St. Peter's Audit Committee members: Richard Nielsen, Gabi Hughes, Greg Lommen

Areas of our Audit consisted of Church Bill Pay and Office Procedures, Payroll, and Endowment Committee. The guide we used for the Audit was the ELCA Compliance Review and Congregation Records.

Church Books Office Procedures and Payroll:

The Church financials for four months were reviewed and compared to bank statements, Council Minutes and information provided by the Church Treasurer. Time sheets were also reviewed for verification to actual paychecks issued and authorized twice per month. The church follows built-in checks and balances as established over the past years by the Church Council. Janine Morrow maintains all records for the required time and disposes of them as required. An audit of the Petty Cash held by the office was conducted and all expenses were accounted for.

Endowment Committee Audit:

Richard Nielsen and Richard Doering met at the church to review the records for the audit. The Endowment Committee meets quarterly. The interest accrued from investments is distributed equally among four categories: Missions and Program Grants, Outreach Grants, Educational Grants and Building Grants. Special requests are considered upon receipt of request. After each quarterly meeting, checks are written to recipients with a letter of transmittal and mailed within seven days of approval. Two signatures are required. Quarterly minutes and checking accounts were found to be accurate and in order.

The Endowment Committee distributed funds to 18 local and national agencies in 2021 totaling \$18,039.97.

The Committee Members are to be commended for their thoroughness and accuracy in supporting our church and the community.
